Welcome to the Children's Cardiomyopathy Foundation (CCF)'s 17th Annual Golf Classic at the Ridgewood Country Club. Additionally, CCF funded three new pilot studies at major universities and sponsored a working group meeting for top experts on pediatric cardiomyopathy.

In October, we will host our first family conference, *Living with Cardiomyopathy*, in Philadelphia. The event will offer attendees the opportunity to hear from medical experts in the field and connect with other cardiomyopathy families.

With your support, we will continue to build on these successes to improve the quality of life for children living with cardiomyopathy. Your generosity today truly makes a difference in the lives of our heart kids and their families.

ABOUT THE CHILDREN'S CARDIOMYOPATHY FOUNDATION

The Children's Cardiomyopathy Foundation (CCF) is a national nonprofit dedicated to finding causes and cures for pediatric cardiomyopathy, a chronic and potentially life-threatening heart disease.

The Foundation started in 2002 with one family's determination to call attention to a poorly understood disease and to take action on the lack of medical progress and public awareness. Seventeen years later, CCF has grown into a global community of families, physicians and scientists focused on improving diagnosis, treatment and quality of life for children with cardiomyopathy.

Proceeds from the Golf for a Cure event will go towards CCF's research programs in partnership with the American Heart Association, American Academy of Pediatrics, and North America Pediatric Cardiomyopathy Registry. More than 305 medical publications and presentations have resulted from CCF-funded initiatives, which has led to improved guidelines for physicians treating children with cardiomyopathy.
