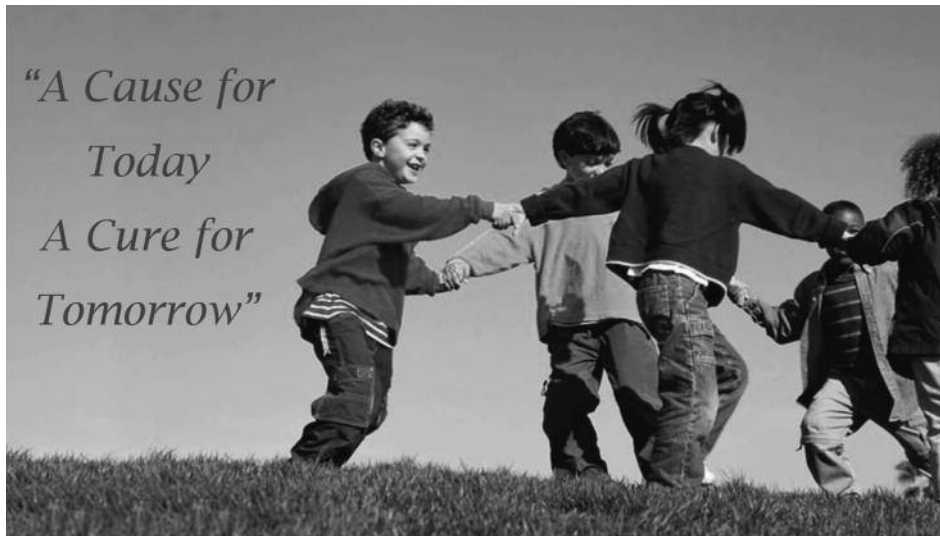

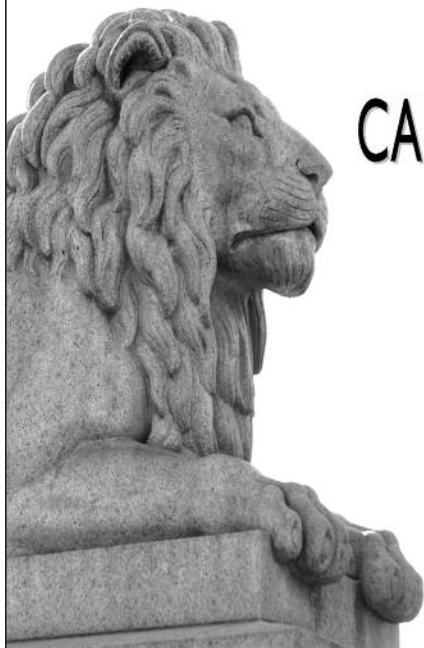



About the CHILDREN'S CARDIOMYOPATHY FOUNDATION

The **Children's Cardiomyopathy Foundation (CCF)** is a national non-profit dedicated to finding causes and cures for pediatric cardiomyopathy, a chronic and potentially life-threatening heart disease.

The Foundation started in 2002 with one family's determination to call attention to a poorly understood disease and to take action on the lack of medical progress and public awareness. Since then, CCF has grown into a global community of families, physicians and scientists focused on improving diagnosis, treatment and quality of life for children with cardiomyopathy.

More than \$9 million has been raised for research and education initiatives, and CCF was the first to establish a pediatric cardiomyopathy biologic specimen repository and to sponsor an international scientific conference on pediatric cardiomyopathy. As a result, 130 articles have been published in scientific and medical journals, providing critical guidelines to physicians caring for children with cardiomyopathy.

The Foundation is an invaluable lifeline to thousands of families affected by cardiomyopathy, offering information, resources and guidance. Over the years, CCF has partnered with several organizations, including the Centers for Disease Control and Prevention; American Heart Association; National Heart, Lung, and Blood Institute; National Organization for Rare Disorders; and the National Society of Genetic Counselors to provide accessible information on the disease. In addition, educational materials developed by CCF are distributed at more than 70 hospitals in the U.S. and Canada.

In looking towards the future, CCF hopes that more lives will be saved and every affected child will have a chance to live a full and active life.
